Introduction

On 1 April 2011, the Shareholders by Special Resolution appointed David Ian Ruscoe and Simon John Thorn, of Grant Thornton New Zealand Limited, as Joint and Several Liquidators of Western Pacific Insurance Limited ("the Company").

Simon Thorn vacated the position of Liquidator on 27 June 2013 and was replaced by Richard Grant Simpson.

Reporting

In addition to our six monthly statutory reports we are also to provide bi-monthly reports to creditors and policyholders in accordance with the Order of the Court dated 14 June 2012. The Order of the Court requires the reports to contain details of the work completed, costs and expenses in relation to the realisation of reinsurance proceeds.

Canterbury Policy Holders

Entitlement to Reinsurance Proceeds

As reported previously, we expect to receive an estimated \$33.9 million from the company's reinsurers in respect of claims made by policy holders for loss arising out of the two main earthquakes in Christchurch, New Zealand on 4 September 2010 and 22 February 2011.

Reinsurance Summary

The following is an update on the claims position along with an estimate of the reinsurance recovery at the time of writing this report.

We expect there will be a shortfall of funds available for claims and also expect that the quantum of claims may increase as assessment of same is completed.

Conduct of Liquidation

We continue to work closely with the loss adjusters to progress the claims. As previously reported, progress had been slower than we had hoped due to lack of availability of engineers. To hasten the processes we have engaged two additional engineering firms to assist with the loss adjustment process.

Our current estimate for completion of loss assessment of the earthquake claims is at least 12 months.

This table provides a summary of the status of the claims as it currently stands:

* Estimated values. As mentioned above we expect that the quantum of claims may increase as assessments are completed

Discussions with the reinsurers are on-going and claims submitted to date with a combined value of \$2.8m (\$3.3m less \$0.5m excess) have been submitted to the panel of reinsurers. These claims have been accepted by the reinsurers and they have offset reinsurance premiums due for 2011 against this claim. We expect a further claim for \$6.9m to be submitted to the panel of reinsures in the next month. As premiums due for the 2011 year have now been offset against the reinsurance proceeds, we expect a full recovery of further amounts claimed under the policy (subject to excess and other costs).
