# Introduction

Stephen Speers Keen (IP#159) and Malcolm Russell Moore (IP#42) of Grant Thornton New Zealand Limited (**Grant Thornton**) were appointed jointly and severally as liquidators (**the Liquidators**) of the following Companies by special resolutions of their shareholders pursuant to section 241(2)(a) of the Companies Act 1993 (**the Act**).

### Business stabilisation

A formal sale process is underway for the solarZero business and/or assets.

## Asset realisations

### Protocols with secured creditors

A protocol letter has been entered into with NZGIF to ensure appropriate rights have been conferred on the Liquidators to handle the realisation processes for certain assets that may be subject to NZGIF's security.

The realisation process is now complete and a partial distribution was made outside of the reporting period (which will be detailed in our next report).

We comment on the main realisations in the sections below:

### Inventory

Inventory was held across seven different sites, across Christchurch, Wanaka, Hamilton and Auckland. The locations were a mix of SZL leased premises and commercial premises. All inventory was collected by our appointed agents at the time of appointment and sold in staged lots via online auction.

All inventory has now been realised, with exception of 80 batteries and 40 inverters housed in two containers (which are being sold separately).

Realisations during the Period total \$1,023,966.

### Fixed Assets

Turners Auctions collected all fixed assets and have sold the remaining assets in the Period for a total of \$41,042.

### Debtor collection

Debtor collections in the Period amount to \$9,654 for SZL. Recovery actions are ongoing for certain debtors (where this is deemed commercially viable).

As previously reported, a significant receivable balance on the SZL balance sheet has been identified and the relevant party contacted. The receivable is being challenged by the relevant party and the Liquidators continue to assess legal recovery options.

### Income tax refunds

The Liquidators have recovered \$195,258 during the Period in respect of pre-liquidation income tax refunds.

### Research & Development tax incentives

During the Period tax recoveries of \$1,226,670 were achieved in respect of pre-liquidation research & development tax incentive credits.

### GST refunds

The Liquidators have recovered \$157 during the Period in respect of pre-liquidation GST refunds.

## Future recoveries

### Remaining assets

Across the Group, the assets that remain to be realised, include:

- Registered intellectual property, including trademark and domain names
- Unregistered intellectual property, including in relation to the solarZero designed and developed 'Virtual Power Plant'
- The solarZero brand and goodwill
- Key licences and agreements

- Inventory (specifically 2,730 batteries that have been installed with solarZero customers that have not yet been paid for, as previously reported)

A sale of these assets occurred outside of the Period and will be reported in our next statutory report.

In addition, the Liquidators have entered into heads of terms regarding sale of the four Schools contracts.

#### Insurance claims

The Liquidators have identified three insurance claims available to SZL and SZESL. The SZL claim has been paid in the sum of \$865. One claim related to property that was owned by SPV1 and has been settled. The other claim relates to pre-liquidation damage to SZESL property. The Liquidators have been working with the Management team to progress the claims.

#### Contract revenue

All live contracts remaining within the Group will be invoiced on a regular basis.

#### Interests in SPVs

SZL holds subordinated interests (behind fees, expenses, senior debt, funding of reserve accounts and mezzanine debt) in the SPVs. Any payments to SZL from the SPVs will be determined after the completion of the sale of the solarZero business or at the end of the customer contracts held by the SPVs.

#### Intercompany creditors

We have identified a number of intercompany advances within the Group, as summarised below.

Recoveries on intercompany lending within the Group are contingent upon recoveries across the Group and the sale of the solarZero business and/or assets. It is not yet known if there will be recoveries from intercompany debts.

## Investigations

As previously reported, we are undertaking a full investigation into the collapse of the Group which is extremely complex. The following areas are being reviewed:

- The Groups' trading performance and business and financial model (including solvency analysis)
- Actions of Directors and Management
- Voidable and preferential transactions prior to liquidation
- Any other matters that might result in recovery for creditors

We have now identified a number of possible claims. Should any creditor wish to provide funding, we welcome them to contact the Liquidators and their staff to explore possible funding options.

## Creditors

### Secured Creditors

At the date of our appointment, we had identified 17 creditors with 34 specific security financing statements on the Personal Property Security Register. We have contacted these creditors and to date:

- Two have removed their financing statements as they were no longer creditors.
- One further creditor has confirmed that it has no claim but it has not yet removed its financing statement.
- We have followed up with three others that have made no claim to date or have removed their financing statement.
- Six creditors with fifteen specific security registrations have either uplifted their assets following review of the security documentation and registration, surrendered their security, or assets have been sold by the liquidators and have filed unsecured claims for any shortfall totalling \$91,362.
- A settlement was reached with one secured party in the sum of \$8,875.
- Three with five specific security registrations have filed secured claims to the value of \$2,932,543.

The Public Trust as Trustee of the SPVs with 7 specific security registrations has filed claims as noted below in this report, although the Liquidators have not yet adjudicated those claims.

### Preferential Creditors

At the date of our appointment, we were advised of 173 employees in SZL, and SZL records showed these preferential claims were \$1,796,880, representing holiday pay owing to employees for accrued entitlement.

We have since adjudicated all employee preferential entitlements (with employees entitled to claim up \$31,820 as preferential for unpaid wages and holiday pay entitlements).

During the period, we distributed a total of \$1,174,091 to 165 employees in full settlement of their preferential claims.

We have confirmed that the Inland Revenue Department has no preferential claim against the Group.

### Unsecured Creditors

At the date of our appointment, the Companies records indicated that there were 598 unsecured creditors owed \$39,086,877.

To date, we have received 300 unsecured creditors' claims totalling \$23,967,353. A breakdown of the claims received per entity is below. Please note that we have received a number of contingent claims against SZL and SZESL based on the maximum potential or arguable claims against the Companies. Claims have yet to be determined or admitted in the liquidations of the Companies.

Note: All balances claimed are subject to interest and costs incurred to the date of payment.

The claims are complex. The Liquidators are yet to review, admit or determine them.

The totals above are likely to include an element of double counting.

Further work is ongoing on assessing the claims filed by Public Trust and updates will be provided in due course.

## Remuneration Report

The Liquidators have incurred time costs during the Period, charged at hourly rates totalling \$558,903, exclusive of GST. The Liquidators were paid remuneration during the Period totalling \$521,517, exclusive of GST, primarily towards unpaid time costs from the prior period. There is currently \$500,808 which has been billed but remains unpaid in addition to unbilled time costs of c.\$229k.

All time and expenses incurred and billed in the liquidation are reasonable and necessary.

A detailed breakdown of the Liquidators' remuneration and disbursements received during the Period is enclosed at **Appendix F**, including a schedule of the qualifications and experience generally of staff at each level. A schedule of the work relating to the remuneration received during the Period is also summarised in Appendix F.

### Secured Creditor Advance

NZGIF has advanced \$314,000 to cover Liquidators' fees and legal expenses including the above.

## Further asset realisations

As set out in this report, we continue to advance our investigations, exploring possible recovery actions to achieve additional recoveries for creditors.

## Estimated date of completion of the liquidation

It is not practicable to estimate the date of the completion of the Liquidation at this stage.

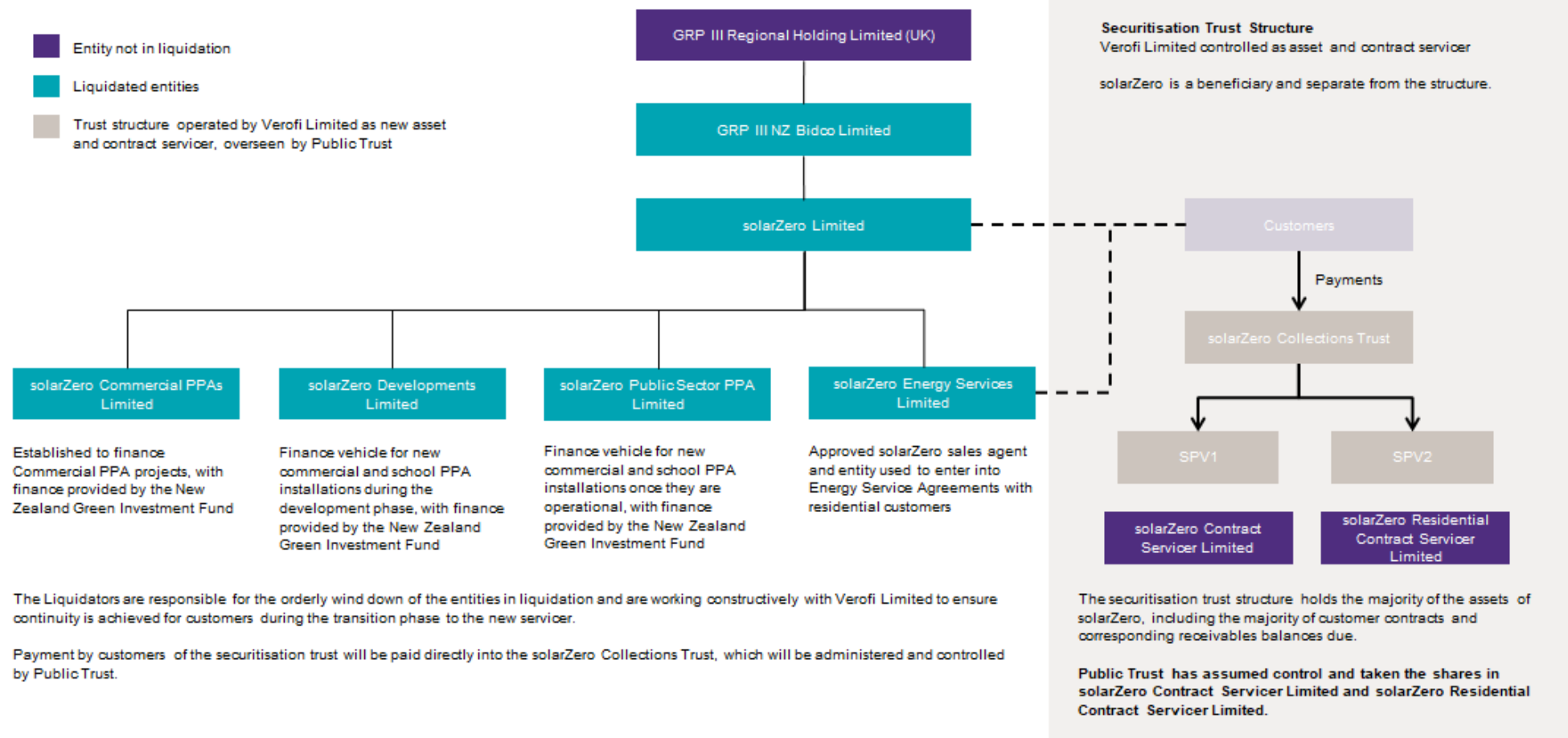

## Declaration of Independence, Relevant Relationships and Indemnities

This declaration is made in respect of ourselves, our partners, Grant Thornton New Zealand Limited (the “Firm”) and any of the Firms associated entities.

### A Independence

Stephen Speers Keen (IP#159) and Malcolm Russell Moore (IP#42) of Grant Thornton New Zealand Limited have undertaken a proper assessment of the risks to the Firm’s independence prior to accepting the appointment as Liquidators of the Companies in accordance with the law and applicable professional standards.

This assessment identified no real or potential risks to the Firm’s independence. Stephen Speers Keen and Malcolm Russell Moore are not aware of any reasons that would prevent the Firm from accepting this appointment.

### B Declaration of Relationships

#### **Circumstances of appointment**

This appointment was referred to the Firm by the solicitors for the Board of Directors of solarZero Limited (in Liquidation). We believe that this referral does not result in a conflict of interest or duty because:

- We have not had any prior dealing with solarZero Limited, the Group or its Board of Directors;
- Such professional referrals are common practice; and
- No documentation was shared with us ahead of the appointment and no advice was provided by us prior to appointment.

We had a meeting with the Founder, CEO and CFO of the Group, and with advisors to the Board of Directors, shortly ahead of our appointment. The purpose was to discuss high level logistics should we need to be appointed, the current financial position and business operations generally.

In addition to this meeting, we discussed the mechanics of the appointment and timing with the Group’s solicitors.

In our opinion, this does not affect our independence for the following reasons:

- It is common (and good practice) to ensure planning is made ahead of any formal insolvency appointment to ensure logistics and adequate measures are put in-place; and
- No advice was provided and no payment was made for the time incurred.

We have provided no other information or advice to the Companies, the directors and its advisors prior to our appointment beyond that outlined in this DIRRI.

### Relevant Relationships (excluding Professional Services to the Insolvent)

The wider Grant Thornton international network has existing business relationships with the ultimate parent of the Group, BlackRock, Inc. A full review of the relationships and confirmation was sought (where required) from all relationship owners to confirm our ability to proceed to take the appointment.

Neither of the Liquidator's, nor the Firm, have, or have had within the preceding 24 months, any relationships with the Companies, an associate of the Companies or a former insolvency practitioner appointed to the Companies.



### Notes

1. As mentioned in the previous reports, a significant number of accounts receivable relate to rebates and/or credit notes from suppliers who have a right of offsetting this balance from their claim in the liquidation. Negotiation is ongoing with certain debtors.
2. As the wider Group is also in liquidation, we anticipate that recovery of the intercompany receivables will be minimal. However, recoverability is subject to the sale of the solarZero business and/or assets and will be determined later in the liquidation process should there be funds available.
3. We have investigated this balance in more detail and contacted the relevant party for recovery, the debt is being disputed and the Liquidators are exploring all options available to them.
4. All inventory is now sold, except 80 Batteries held in two containers in the south island.
5. Other assets & receivables primarily relate to R&D tax incentive (\$1.2m), commission paid on retainer (\$984k) and prepayments (\$394k). The recovered value to date represents the R&D tax incentive and income tax recovery. We have been in contact with the parties of received retainer and prepayments, these recoveries are ongoing.
6. SZL has debt facilities with the two SPVs. This debt is not cash advanced to the SZL, rather a credit against this account for the transfer of the complete systems into the SPVs. This debt facility is subordinated and has the lowest entitlements for any future repayments. Any repayment of this amount will be determined by the sales campaign of the sale of the solarZero business and/or assets, which is ongoing.
7. Other fixed asset realisations mainly comprise of the sale of office furniture, computer equipment and other tools and machinery, all of which has been sold.
8. We have sold all Company owned vehicles and have accounted to the secured party for the proceeds from the sale of vehicles under finance. The remaining claim of the secured party will rank among unsecured creditors.
9. We understand that this relates to the residual entitlement to the funds in the SPVs once all debt facilities and associated costs have been paid in full. Any repayment of this amount will be determined by the sales campaign of the sale of the solarZero business, which is ongoing.
10. SZL is a GST group representative for the wider solarZero Group. We have filed the pre-liquidation GST return for the group and the amount recovered to date reflects the amount that was refunded by the IRD.

11. We have obtained copies of the Company's payroll data and have calculated employees preferential and unsecured claims based on this. This was adjusted based on updated information from the Company's payroll provider, and subsequently paid during the period.
12. Right of use assets relate to the accounting treatment of the Company's property leases under IFRS16. There were no recoveries from the right of use asset or the lease bond due to the Company's obligations under the various lease agreements, as reflected by the lease liability. The revised lease liability figure is the value of claims received from the various Landlords. Claims have not been adjudicated and may change.
13. This relates to claims from creditors for breaches of contract, damages, etc. These claims are complex and we have not yet adjudicated them. In our previous report, some of these claims were included under trade creditors and we have reclassified them under other unsecured creditors in this report.
